Scope of The Pennsylvania Agriculture Collaborative

The Opportunity

Food and agriculture are foundational to Pennsylvania's economy and state leaders must prioritize the advancement of these industries accordingly. The needs and opportunities inherent in "future-proofing" to ensure a safe, abundant, and sustainable food and agricultural supply present a path to transform our economy, elevate industry, and create and sustain jobs throughout our state.

We already have everything we need to be successful: a legacy of agriculture; a diverse industry with strong, existing, and growing businesses; world-class research institutions and impactful non-profits; a nation-leading Farmland Preservation Program; and abundant water and energy, just to name a few.

Increasingly, other states (and nations) are seeking to transform food and agriculture, as leaders navigate the complexities of global food supply in the context of ever-shifting geopolitical conditions and a changing climate. Pennsylvania must ensure that we are not left behind or playing catch up when there is a compelling case that action is needed now to capitalize on the opportunities before us.

The Collaborative's Role

The Pennsylvania Agriculture Collaborative is a statewide network that brings together leaders from industry, government, organized labor, nonprofits, and academia to create the conditions for innovative, technological, and market-driven solutions to ensure a sustainable, safe, and abundant agricultural supply within Pennsylvania's economy while creating jobs.

The Collaborative is —

Public-Private: Driven by private sector leaders and champions from state government who share a commitment to Pennsylvania's food and agricultural industries. Nonprofit, organized labor, academic and regional organizations also play important roles in driving the Collaborative's action agenda.

A catalyst & enabler: The Collaborative drives action around food and agriculture, creating the conditions for infrastructure investments to be made in Pennsylvania through compelling messaging as well as policy and regulatory frameworks.

A driver of sustained commitment: The Collaborative is designed to mobilize and sustain the long-term, public-private commitment needed to realize the economic opportunities of food and agriculture in the Commonwealth.
